

Pig biosecurity management plan: Checklist

Protect your pigs from pests and diseases

Know your risks! A biosecurity management plan, when followed, will help you manage your biosecurity risks. This biosecurity checklist represents best practice to protect your pigs from the introduction and spread of pests, weeds and disease.

To develop your biosecurity management plan, tick Y for the practices you currently do, N for those you don't and N/A for those that don't apply to your current situation, noting it is recommended to review your plan whenever your biosecurity risks change.
